## **POOL RULES**

The following rules are for the health, welfare, and safety of all members. They have been established by Management, as required by SCDHEC, and approved by the Board of Directors. The primary purpose of the pool rules is to provide enjoyable recreation for the residents. Failure to comply with any of these rules may be sufficient cause for immediate suspension or cancellation of pool privileges.

The Pool Monitor is responsible for enforcing the rules and is in full charge of the pool at all times. Parents are required to caution their children to observe all rules and obey the Pool Monitor. Children and adults shall be expected to show proper respect and cooperation at all times. The Monitor shall have the authority to suspend pool privileges for any period up to a week, for good sufficient cause. The monitor may recommend to Management suspension for periods longer than a week. Residents having grievances are required to refer them in writing to Management to be viewed by the Board of Directors. The Pool Monitor will be furnished a list of all qualified residents and their Unit Number.

- 1. The pool facilities are for members and their guests ONLY. Residents must furnish the Pool Monitor or Board of Directors member with their unit number to be checked that regime fees are up to date. There is a limit of two (2) guests per Unit and no more than (4) people per unit at the pool at any time. Residents must accompany guests at all times. Residents accept the responsibility for the actions of their guests.
- 2. All persons using the pool do so at their own risk.
- 3. Huntington Homeowners' Association is not responsible for injuries or loss of property
- 4. Absolutely no glass containers allowed in the pool area.
- 5. Children under the age of 18 must be accompanied by resident sponsor over the age of 18. (At least one adult for no more than 2 children.)
- 6. Boisterous or rough playing, running, foul or abusive language, loud music, or causing undue disturbance in or about the pool is prohibited.
- 7. No pets, bicycles, skates, skateboards allowed in the pool area.
- 8. Proper swimming attire is required. No cutoffs, t-shirts, or diapers (e-coli-bacteria) allowed.
- 9. Absolutely no bandages or bleeding wounds allowed in the pool.
- 10. No diving permitted.
- 11. Dispose of all trash in the garbage cans provided.
- 12. Any person detected destroying or damaging pool property will be responsible for its repair and/or replacement.

These rules may be revised or additional rules established as considered necessary at any time by Management, subject to approval by the Board of Directors. Situations arising, which are not specifically covered by any rule herein, or special circumstances will be handled at the discretion of the Pool Monitor and will be reported to Management.

## NOTE:

A First Aid Kit, lifesaving ring and rescue pole are located in the pool area. Inside the first aid kit are instructions for rescue breathing. A telephone is located on the wall beside the clubhouse door. Dial 911 for all emergencies.

Pool closes at 9PM by order of DHEC. No lifeguard is on duty.
